EDITOR'S COMMENT:

The American Opal Society as you all know is an educational organization and the OPAL EXPRESS is its official publication.

From time to time we have submitted to us for publication very learned scientific papers. I feel that to enhance our image of an organization of great learning, scientific papers of inimitable quality should be published. Please keep a dictionary by your elbow as you read as much of the following paper contains words over four to six letters long and scientific words such as "expletive deleted", and "finger."

A CASE FOR "CASE POINTERS"

This past Christmas season we did several Craft Festivals and Gem Shows as we do each year. However this was not exactly our best selling year, so I had plenty of time to finish my intensive research on "Case Pointing "This culmination of my years of research into "Case Pointing" is now being published for the first time anywhere.

In case you don't know what "Case pointing" is, it is because you I may be a case pointer yourself Most case pointers are recognized only by a special breed of un-case pointers known as behind-the-case sitters, or in common vernacular as sellers or dealers

The first and most common is the straight finger pointer who points at your wares while talking to a companion Boring, no fun' Next is the dainty or little finger pointer whose little finger barely touches the glass of your case more interesting is the cross-eyed pointer who makes the time go faster by pointing about 6 inches above and 3 inches to the left of the item they are looking at and say "How much is that? No, not that one, that one! No, no, that one!" always moving the finger so that it never lines up with what ever it is. This is good for at least 15 or 20 minutes while the seller eliminates everything within a 12 inch radius Finally the vendor triumphantly holds up the item for the customers closer view. Now if this customer is a real pro, he or she will immediately answer, "That's not quite what I had in mind," then administer the coup de grace by moving to the next case and saying," How much is that?"

The next finger pointer is between 6 and 10 years old and has just finished a double scoop ice cream cone, one scoop of which melted over both hands. With and enthusiastic "Oh, look at that!" he firmly points with all 10 fingers and both palms on your glass leaving smeary mementos of his appreciation.

Another is the no finger pointer. This is a young mother with a baby in her arms. "Ooh look, Babykins at the pretty pretties." If you are lucky Babykins only drools on your case; if not down goes a wet lollipop in your jewelry. A variant of the baby in arms, no finger pointer, is the finger pointer blocker brigade. It consists of three to six hefty young matrons pushing strollers with an equal number or more of aqualung, clawing, grabbing,

mini-monsters. This dreaded phalanx appears only at times of greatest crowd density. It is a well disciplined force that comes charging down the aisle to come to a screeching halt in front of your booth, blocking any potential finger pointers from getting within five feet of you. Then with sightless eyes, staring at your cases, spend the next forty-five minutes telling each other of the cute things Little Suzie or Junior did, 'while Little Suzie or Junior are busily clawing and tearing the bottom of your booth to splinters and ribbons. If the brigade is up to full strength of at least five, the two outside stroller pushers will wheel around at right angles to block both ends of your aisle and effectively seal off you and all other merchants in the area.

When this group finally moves on, without seeing anything in your case, along comes the accident prone finger pointer. While she is pointing with one hand, the other holds a large brimming Pepsi. When directly in front of and above your case the Pepsi elbow will be bumped spilling 90% of the cola on your case. This will probably wash off all of the drool and some of the hand prints.

A real Headache if the "Rich Bitch Pointer," with large diamonds on each finger. She points with the back of her hands facing your case, meanwhile dragging her diamonds down across your glass, leaving unrepairable furrows on your case windows. Usually explaining, "You don't seem- to have anything suitable for Fido." She herself only wears jewelry made of platinum and diamonds over 5 carats.

The Middle Finger Pointer makes stabbing gestures at your goods with this finger. It looks very much like an upside-down version of the obscene gesture the Los Angeles Freeway drivers greet each other with.

So much for the harmless ones; now to list some of the more dangerous. First is the bent finger pointer. The finger is pushed firmly against the glass and begins to bend backwards. The customer is usually in a spirited conversation with a companion, as the talk becomes more animated, the finger bends further and further backwards. Just at the point where she is telling a friend how much bigger and more colorful the opal she has at home is than the best in your case, the finger becomes bent to such an alarming degree, that you, the merchant, may begin to feel the first signs of panic such as "Oh my God!; that finger is going to break and I am going to be sued for maliciously placing my display case right where it should be."

Unfortunately, this is only the first degree of dangerous. Customer variations of this go all the way through from single finger, palm and full forearm to both hands, and large heavy purses. To those in the trade these people are known as glass pushers, or more commonly **!! (expletive deleted) glass pushers. The greatest danger of all and the source of the most frustration is a variation of the finger pointer called the Elbow-leaner. This particular species is male, weighs about 250 pounds and wears a large, bulky coat. He is always accompanied by two or more similar types between 250 and 300 pounds with large, bulky coats. If smoking is allowed in the building, a large, obnoxious smelling cigar is always present. This group comes up all at once, arrays itself across the front of all your cases, floppy coats obscuring what the 250 pounds does not. One or both elbows are leaned on your cases causing the glass to bend inward, making distressing crackling noises. It will do no good to try to say anything to this group because you won't be heard over the loud boisterous conversation and head-splitting laughter, that will go on for a good half-hour or more. The saving grace that prevents "Merchant Madness", is that this nightmarish trio or more only shows up occasionally, then only at peak selling hours.




